

The Sounds of Silence

Some mornings the place is engulfed in such soundlessness that I fear a plague has hit in the night, and I am the only person left on the planet. Sometimes the stillness lasts until a solitary car goes by midmorning. Phew! I breathe a heartfelt sigh of relief. In this little corner of rural Corfu. far from main roads and the bustle of Town, you occupy an older island. As Lawrence Durrell wrote of 1930s Corfu, 'the quietness alone makes it another country.' Yet other writers seem to disagree. In The Tempest, Shakespeare describes Prospero's isle (which many sources identify as Corfu) as being 'full of noises'. In contrast, Lawrence Durrell, in Prospero's Cell, quotes his wife Nancy as saying (of Kalami) 'the quietness alone makes it another country.' In her 1960s novel 'This Rough Magic', Mary Stewart, during a tongue-in-cheek discussion between the main characters, cites Shakespeare's 'full of noises' description as proof that Corfu truly was Prospero's island. The contrast persists today. 'Greece is undeniably a high-volume country,' wrote Mark Dubin in the Sunday Times, 'especially when the countryside fills up with returned emigrants from Athens and abroad. Villages reverberate to the sound of mothers with foghorn voices summoning their children, or the more aesthetic clangour of church bells. You always know when a party has won an election, or a

team a football match (no more so than with Greece's surprise Euro 2004 football victory; nobody in Athens slept that night). Easter Midnight services are punctuated by dynamite explosions and, in some locations, improvised rocket barrages... Yet juxtaposed with all this can be an all-encompassing quiet, if not to say serenity.' Indeed, the Greeks gave us the grimmest synonym for the word noise:

cacophony - literally 'bad sound'. The English language also has din, row, explosion, tumult, blare, shriek, bark, racket - all cacophonies with an unpleasant nuance, noises you would want to avoid. So, is Corfu filled with quietness or is it 'full of noises'? How can we reconcile this conflict? I think we should perhaps examine what produces the sounds. Natural noises generally do not disturb, except when they become extreme. Some sounds inspire calm, induce slumber. The background buzz of bees when the pollen rises on a thyme-purpled hillside. The chirk of cicadas in the midday heat, summer's balmy background vibration. The plash and gurgle of autumn rain. The distant boom of waves on a winter-empty strand. It's even possible to sleep through the banshee rush of a southerly gale. Contrast these with man-made sounds: the strident shriek of an eternally nagging housewife (my exsister-in-law; awesomely annoving!); the constant whoosh and roar of passing traffic; dogs barking throughout the night (they bark when tied up, an unnatural condition created by the human owner); the boomda-boomda-boom

of a hideously amplified car stereo; the destructive whizz and bass buzz of a chain saw: and worst of all, the rumble and slam of a bulldozer that you just know is ripping up another unspoiled corner of the island, the terrible racket that strikes even in the depths of the countryside. We return to the 'noises' of Shakespeare's Tempest, which by reading on we find are not disagreeable ones: '...the isle is full of noises, sounds and sweet airs, that give delight and hurt not. Sometimes a thousand twangling instruments will hum about mine ears, and sometime voices that, if I then had waked after long sleep, will make me sleep again...' So Corfu IS full of noises, but natural or perhaps supernatural - sounds, rather than cacophonous ones. And indeed, we can sleep through nature's noises, while man-made ones intrude. The Greeks even have a word for that most lulling and silent of sounds: 'flisvos', the lapping of wavelets on the shore.

Dithering Spring

Spring really is delayed this year, with night-time temperatures well below zero knocking early flowering on the head. A few days of sunshine, in which the wild flowers basked, have given way to more rain, and mud, mud, mud everywhere. The local beekeeper anxiously puts Spring a month behind, while the weeping willow which provides my own yardstick sent out its first leaves eight days later than last year (28th February instead of the 20th). Of the other trees, many are not even bothering to leaf even now in late March. If global warming is really taking place, I wish it would hurry up!

So, imagine his surprise when the hardy hobbits-with a little help from their friends-came up trumps.





Athens may not have enough cash to meet its month-end obligations. But even if it somehow manages to squeeze through, it needs to repay €450m to the IMF on April 9. And then Athens faces a really big hurdle that may be insurmountable.

Two Greek Treasury bills totaling €2.4 billion mature on April 14 and April 17. Most of this debt is sitting in Greek banks, which have been rolling over these bills with emergency funding obtained from the ECB, rather than demanding repayment from the Greek government. But

these two upcoming bills are different because at least €500 million is owed to investors outside Greece who are going to ask for their money back.

Greece To Default Before April 14, Sending Shockwaves Around The World!

If Greece can't pay, it would be a default, which in turn will trigger acceleration clauses in Greece's other debt obligations that would require immediate repayment of those debts too. That is when Greece blows up and sends shockwaves around the globe, which will particularly rock the ECB as well as with the remaining depositors in Greek banks. But I think Greece will actually blow up before April 14th.

The ECB has purchased from European banks almost all of the Greek paper these banks previously held. In other words, just like occurred when Lehman collapsed, there will be a bank bailout, but it looks like there will be a difference. Cyprus is a more accurate comparison because the losses will be paid by bank depositors, rather than put on the backs of taxpayers. And maybe this time, even the holders of bonds issued by Greek banks will be forced to take losses, which is where the global impact could be felt.

There have been a lot of fund managers buying Greek debt in search of the high yield it offers, the high yield of course arising because of the high risk. These guys are betting that the ECB will not let Greece collapse, but it now looks like the ECB, the IMF and the EU are forcing Greece into bank-ruptcy, which is a message that the Greeks themselves are increasingly coming to grips with.

Greek Bank Runs Accelerating Into A Full-Blown Panic

The run on bank deposits in Greece has been fierce. From a peak of total deposits of nearly €240 billion six years ago, deposits have collapsed to the lowest level in ten years to an estimated €130 billion today. Some €30 billion of that amount has been lost just in the past three months.

In other words, Greek banks have lost an astounding 20% of their deposits in the last three months, indicating that the multi-year run on Greek banks is accelerating into near-panic conditions.

Greek Banks Now In A Death Spiral

For years, the Greek government has been kept afloat by the Greek banks. The government was issuing short-term Treasury-bills which the Greek banks were buying. The money the government received from the banks enabled the government to keep its head above water. Athens spent this money as rapidly as it came in.

The Greek banks, in turn, were then using these newly issued Treasury-bills as collateral to borrow money from the ECB. To give you an indication of the size of these borrowings, they rose more than \in 10 billion in just the last month to over \in 70 billion today.

The Greek banks have not been borrowing from the ECB by choice, but rather because of desperation. They are in a death spiral, losing deposits and getting stuck with bad loans that can never be repaid as the Greek economy withers away, which is now forcing the ECB's hand.

ECB To Steal Money From Greek Bank Deposits The only way the ECB is going to be repaid is by stealing money from bank depositors, just as it did in Cyprus with the "bail-in" the ECB imposed in that country. So to protect its position, the ECB will not let the total amount of deposits in Greek banks shrink to an amount less than what the banks owe to the ECB. And as borrowing from the ECB grows while deposits shrink, we are rapidly approaching the point where this cross-over will occur.

Does anybody without a PHD understand the Greek electric bill? Last winter the missus and me were getting 700 Euro plus, bills, so I took some time and looked at my last few years bills and came to a conclusion. Not that electric is a rip off, mind you it's pretty close to it!!! But, if you have a normal domestic residence and your usage goes over 2000 units in the 4 month account period, then your bill seems to automatically double, you go up into a different band of charges.

Now I know that there are a load of know it all's out there, (Who usually know nothing) who will disagree. But the proof of the pudding is in the eating to coin a cliché. This winter despite having an extra family member deciding to stay with us for this winter, my average monthly bill is around 75 Euros, 300 over the 4 month period. HOW, Well I'm a gonna tell you.

First I found out the wattage and Kilowatt per hour usage of everything in my house. If you do not know how to do this, go to <u>http://</u> <u>www.cryer.co.uk/</u> and it explains everything you need to know. I then implemented a regime of simple economy, for instance, I was running 3 freezers so I cut that down to two for a start, also by keeping my electric usage within 15 units every 24 hours this alone will keep your bill under the 2000 unit limit. Did you know that leaving a computer on for 24 hours even a laptop uses about 2 units in that period? I changed my old fashioned kitchen spotlights to energy savers, stopped using electric fires or worse electric radiators. Went to gas instead. Alway's turn off lights not in use, or the tv if not being watched. It was all simple stuff and took only a change of mindset to

get used to it. BUT IT WORKS. TRY IT. Also did you know that those awful inaccurate 2 month estimates can be turned into a correct reading, simple log on to <u>www.deddie.gr</u> and enter your meter number and the reading, do this between the 12th and 18th of the second month, then when the estimated bill comes, it will be a reading of actual usage not a wild guess by the electric board. This site is in English and very simple to use.

I see the police are nicking Brit cars that have been here to long, Bravo! about time, I pay a 1000 a year to tax my car, plus insurance and MOT. I just had to renew my Greek driving licence as well, 160 Euros, so why should arrogant Brits run around in Untaxed and Uninsured vehicles, NICK 'EM all I say. Another thing to be aware of according to whispers heard around, There will be a crackdown at the airport this year on Brits doing illegal taxi transfer's, so watch out!!!

You know whats really ticking me off? The EATA. and the theft of mail to and fro England. There is an epidemic of thieving going on, we can no longer send or receive packages through the Greek postal service safely. I sent a registered letter to Bulgaria, a Christmas card with a small financial gift inside, well disguised, the letter arrived was signed for and found to be empty. It had been slit open the contents removed and resealed, as it was signed for on delivery, no recourse possible. Family DVDs of Christmas, stolen, packages from UK to here, stolen. We can do nothing about it, there is no ombudsmen no one to complain to. If you go to the main post office they just shrug and basically say "TOUGH" I have lived here for 25 years plus and

never had this problem. I think all Brits should get up a petition or do a demonstration in Corfu to try and get some attention to this problem. Maybe the Agiot could organise this if we can get the editor sober. (Only joking McGovern!)

ALBANIA: COMPARISONS OF POVERTY

My flatmate, <u>Adrian Bashkim</u> <u>Dardha</u> who is one of the "Grand Master" chess players in Albania, ranked #7. He fell on hard times having been made redundant 2 years ago, and was living in a tin hut because he had no money to pay rent for an apartment. Social security benefits here in Albania are 20 Euros per month. An apartment costs at least 200 Euros per month. Go figure!

Horrified to see first hand that Albania is country where being "unemployed" means you will probably be dead from starvation or exposure or illness within 2 to 3 years. I have started to find the "tin hut" villages where those without jobs live with no heating, no fresh water, no health care and very little food. I could cry because I feel so helpless. I just don't know what to do, but I cannot bear to see people like this. The temperatures recently fell to -7 C and people are dying. It just doesn't seem right for me to be living comfortably in this nice warm apartment block.

I'm thinking of the homeless and dying people in Albania. I can't sleep properly because I am so concerned for them. This coming Friday morning I am meeting with the ex-Governor of this part of Albania, plus another friend from the Baptist church in Sarande, plus Adrian Dardha (the chess Grand Master) who was homeless but now has a home with me.

EDIT: I will leave the original text I posted "as is" below. But the above goals are best achieved by working through the existing Lidia Foundation christian charity in Albania, which is head-quartered in Sarande. I have posted links to the Lidia Foundation on a more recent thread. The Director of the foundation is Ibrahim, who is also qualified as an EN&T Doctor. Please continue to chat there!

ORIGINAL TEXT: We are

founding a charity to help the homeless. The plan is to create "farming communities" by donating an initial stock of animals for breeding, and seed for sowing, plus tools and training in basic agricultural skills that will enable them to "multiply" the gifts that they received, and provide food and income for them in the future, through the fruits of their labour. We will start this as a pilot scheme in the Sarande area, with a view to "roll out" to other homeless communities in Albania later on, after the pilot has proven successful.

troubled with kitten-bearing.

Some time ago I had fourteen assorted cats and kittens; today I have two cats and one kitten and two of those have been with me for less than six months. Four cats have died from various ailments in the past two years, but I have no idea where the other ones have gone.

The life of a cat is very precarious locally; crazy traffic, savage dogs. Hawks, eagles, snakes all take their toll; even an owl or a rat may make a meal of a tender kitten.

Six months ago I took in two cats as wards while their owner went bck to Britain for the winter. The four cats that I had at that time objected violently and the visitors needed to defend themselves The male took refuge strongly. under the bedside cabinet and the females on top of the organ from which they held off all comers. After four days the tabby escaped and I later was told that she had found her way to home where she was being cared for by neighbours. The tom was made of sterner stuff and wore down the opposition and even won over a resident tabby. The others swore at me regularly for the disruption and eventually disappeared.

Josephine with her coat of many colours, the remaining tabby, has recently become a Hundred Euro Cat. Her latest pregnancy went disastrously wrong needing a visit from the vet to remove a kitten stuck halfway and then an operation to clear the remaining ones which had died inside. At least she will not be any longer When I took in the two visitors it was under stood that if they settled they might remain permanently. Captain, a handsome shaggy-coated ginger tom with one eye and the most elegant tail on the island is now firmly established , sleeping every night beside my pillow and trying unsuccessfully to share my meals.

The kitten, Putticles, is a survivor of Josepine's litter of last autumn. He is a juvenile delinquent, going everywhere where he should not go and doing everything that he should not do. Captain, Josephine and I regularly slap him down but it makes no difference, he persists in his intransigence. When we are about him he runs to hide under the bed only to emerge a minute later to spring on to my lap to be petted. He even managed to prise open the lid of the tin in which I keep the dry cat food in order to enjoy a midnight feast.

Purricles's father is a big ginger and white tom belonging to one of my neighbours. He had taken to visiting regularly when I feed my cats. I have named him Hoover because he cleans up every trace of food left by the others and eats it at remarkable speed and efficiency, merely sucking instead of chewing. He must have a very strong digestive system.

Some years ago I lost six of seven cats one night when I was late back from giving a concert. They had found food that was poisoned and died in agony. The lucky one vomited and drank only water for the next week. These days I think that nobody puts down poison as most households here have taken in pets, cats or dogs.

When I had more cats many of them were members of the Agios Ioannis Felharmonic Choir that used to give monthly performances in the open space across the street from my bedroom window. I would bear with their efforts until they became excruciatingly avant-garde. At convenient places around my home I have Heinz plastic bottle used now as water-squirters. Thev have a range of about five meters, more than enough to reach across the narrow village street and I use them to drive away any animal that is being a nuisance. I needed only to open my bedroom window and to deliver a two-second jet to put an end to the choral society's efforts. These days, none of my cats shows any musical aptitude. The group performs in the plateia. Distance ends enchantment.

Greek microbreweries hopping amid economic crisis

ATHENS – After a day of exploring ancient ruins or lying on the beach under the hot Mediterranean sun, who wouldn't want a cold, fresh, locally brewed beer?

A new wave of Greek microbreweries is hoping to capitalize on quenching the thirst of travelers and locals despite the country's ongoing economic crisis.

"Our island lives from tourism," said Spyros Kaloudis, who founded Corfu Beer after he got fed up with vacationers drinking foreign brews on the island in the Ionian Sea.

"Tourism means experiences – to complete the experience, I wanted to create something local," he added. "I didn't want it to be another souvenir but

a product that could be consumed daily by visitors."

After eight years of planning, he perfected his first beer in 2008 – at the same time the financial crisis plunged Greece into the deepest recession in Europe. Despite the economic headwinds, he's now brewing five beer varieties and expects to launch two more this summer.

Corfu Beer and a dozen other microbreweries that have opened in Greece in recent years stress that entrepreneurship in the southern European country isn't easy.

But they're hoping business will flourish if newly elected Greek Prime Minister Alexis Tsipras fulfills his promises to end the steep tax hikes, harsh spending cuts and other austerity measures imposed by European leaders who extended loans to the country to stave off economic collapse.

Many Greeks voted for Tsipras' Syriza party because they blame those measures for the country's high unemployment and dismal economic growth. Greece's gross domestic product has contracted about 30% compared to seven years ago, unemployment has reached 26% – among youth, the jobless rate is 60% – and a third of the population is living under the poverty line.

"Things would definitely be better" if austerity ended, said Yannis Paraskevopoulos, one of four partners who founded the Santorini Brewing Company in 2012.

Microbreweries started cropping up in Greece in the early 2000s. But two years ago, the industry began taking off after lawmakers eager to boost entrepreneurialism overturned an 1822 law that forbade producing anything but beer in breweries, freeing producers to experiment with new products such as soft drinks and unleashing new investment in the sector.

Today, Greek microbreweries produce just 1.5% of the beer consumed in the country. But many are winning international awards, expanding production, raising new capital and rushing to satisfy international demand as local interest in their beers also grows.

It's a success story in a landscape dominated by bleak headlines about a possible "Grexit," or Greece abandoning the euro and destabilizing the European financial system.

"It's truly unbelievable that microbreweries are developing in this environment," said Kaloudis. "I believe it's due to people's sentiments. By choosing local products, they want to help their country and local economy."

Part of the microbreweries success stems from taking advantage of the crisis as cash-strapped Greeks have turned from drinking hard liquors to cheaper beer.

Consumption of alcoholic beverages in Greece has fallen by 45% in the past four years as Greeks tighten their belts amid the economic crisis, according to the Greek branch of IRI, a market research company. But Greeks drank 3.2% more beer in the first seven months of 2014 than the year before, and microbrewers expect new data will show beer drinking skyrocketed in the summer months.

The shift reflects wider changes in Greek habits. Prior to the early 2000s, pub culture and local brewing were alien to the country. Taverns and restaurants usually offered only two choices of beers.

In mom-and-pop establishments in Greece today, it's still hard to find a locally produced brews. "We have to train them to learn how to preserve and serve a fresh beer," Kaloudis said.

Many microbrewers shepherded their resources wisely amid a period of slow growth and now are reaping the rewards of sticking with their dreams.

"The crisis helped us make more careful moves, not investing in unrealistic production facilities for the times," said Sofoklis Panayiotou of SEPTEM beers on Euboea, the second-largest Greek island.

Today, SEPTEM — which has won international awards for its brews and has been ranked as the best Greek beer on Rate-Beer.com for the past four years — is planning to ramp up production. The move will take the microbrewery from producing nearly 80,000 gallons of beer a year to up to 264,000 gallons, Panayiotou said.

In the past two years, the Santorini Brewing Company has tripled in size, Paraskevopoulos said. Now, its goal is to increase the current annual production of 300,000 bottles by 40% next year to meet demand.

"Microbrewing is an expensive game, and we also started right in the middle of the crisis," said Paraskevopoulos. "But we dared, and it proved to be extremely successful."

Kaloudis hopes his industry's success can lead the way for the rest of Greece.

"I don't believe in the monoculture of tourism," Kaloudis said. "This crisis has been a unique opportunity for small Greek producers to overcome it."

In my career in the property industry I have seen two major reces-They have differed sions. greatly. In the early nineties' recession, interest rates were around 15% yet in the current recession the UK is allegedly on its way out of, interest rates are at an historic low of 0.5%.

ANY recession is actually good for the property rental market so good for you if you get into it. The first recession in the nineties when interest rates climbed to 15% and above proved prohibitive for those looking to purchase a property - so, guess what, they rented and this swelled demand. For many of those who owned a property and struggled with the mortgage payments they rented it out and went home to Mum and Dad! Again - good for the UK rental market. For those struggling with mortgage payments who needed to cut and run, they sold their properties at a knock down price - good for investors!

This latest recession was predominantly bought on by reckless lending by our banks so today borrowing criteria is now tight. Guess what - people rent because they cannot find a large deposit nor match the tight lending criteria! Also - because interest rates are low (and property prices), buying a property for rental is an excellent proposition.

In my experience, property rental flourishes whatever the financial weather.

How Do Recessions Affect watch too much TV! Let's face it, show the long running TV "Airline" all about Easyjet ONLY ever shows you what goes wrong. How interesting would a show that spanned some six series have attracted so many viewers if it just showed people checking in, getting on a plane and having a great experience?

There have been many TV about "tenants shows from hell". Great viewing material and entertaining but typical media hype. Just exposing the negatives. People only pass stories on about property rentals that are negative because they are interesting so these stories stay in one's mind.

Yes tenants can cause problems but these problems can be prevented by employing a letting agent who is more interested in the quality of tenant than the quantity and turnover of business. Also by purchasing the right kind of property in the right area. I had the privilege of working with one of the largest independent letting agents in the UK and I still work for them on a consultancy basis from here on Corfu. I know the industry and I know these people are the very best.

They became the largest letting agent by only taking on good quality properties and housing good quality tenants. When I was UK based working for this agency I met hundreds of people who used other agencies only to get their fingers burned. I am happy to say that we gained so much business from such people passing their property to us to manage.

What Goes Wrong In This Industry?

Sadly, investors entering the property rental market without sound advice sometimes have some preconceived ideas about what to buy to rent out. I have lost count of the number of people who came to me saying they have purchased a city centre flat and furnished it. The misconception is that Tenants do not drive, they all work in the city centre, walk to work and do not own a stick of furniture - classic mistake! By purchasing such a property and insisting it is let furnished only limits your market and reduces your rental potential therefore your income.

Another way of getting your fingers burned is to trust advice from a UK estate agent about rental potential and what exactly to buy for rental purposes - let's face it estate agents are there to sell properties. One lady I dealt with was encouraged by an estate agent in the UK to purchase a three storey townhouse and furnish it to a high standard for letting. The estate agent advised her that she would achieve a monthly rental figure of £1,200. After six months advertising the property there were no takers (wrong market) so she came to My advice was sound but me. harsh "flog the furniture and decrease the rent to the correct market level of £750 per month". She did and it let via my agency. So she lost over £7,000 in rental income due to bad advice (not to mention the cost of the furniture purchased from Ikea!)

The estate agent in the above example is the "shark" in the industry. In my career in property I have NEVER trusted an estate agent and I advise you not to! (when it comes to rental advice anyway)

Buying a property from a private landlord with a tenant in place is another classic mistake. One has to ask oneself WHY a landlord with a successful let wants to off-load it. When I was UK based working in the industry I NEVER took on such properties as they were always a car crash and I always advised investors to stay well away!

Choosing what to buy and where is crucial. Quite simply rubbish attracts rubbish. As a property "nerd" I watch all the property programs and programs such as "Benefits Britain", "Homes Under The Hammer" etc. etc. and I was heartbroken when a piece appeared on one such program last week. A chap who worked for Royal Mail fell into the trap of buying a property without seeing it on the advice of a "property investment advice company"!!! Yes it was cheap and promised a good return via rental. However, he later found out that it was in the very worst area of the city and attracted a succession of poor tenants and cost him thousands in lost rent and damage. He now doubts he can sell it. He had worked hard all his life and purchased this property as a pension and to hand to his children. Classic mistake. I always advised investors considering a purchase to drive to the street they were thinking of buying in of an evening and observe for an hour or two. You would be surprised at how many changed their minds!

Buy a bad property in a bad area and you will only attract a bad tenant which brings dilapidations, antisocial behaviour and rental arrears. These properties look good on paper in terms of the purchase price and "potential" return on your investment. However, bear in mind the average tenancy length is

some 2 years and if you attract poor tenants who leave owing a few months rent each time you let the property – how much is eaten away from your bottom line return?

Stories circulate about tenants from hell which often put people off the thought of investing in rental property in the UK. I can respectfully challenge anyone to tell me such a story and I will tell you why it went wrong and who was at fault (usually the estate agent influencing the buyer to buy a pig-in-apoke or a bad letting agent).

Over here on Corfu I have met a succession of UK ex-pats who came over having sold their property and had a lot of capital behind them. Some had regular income prom private pensions and some rely on a state pension. One particular person who I will call "John Doe" for reasons of professionalism told me recently that he came over here with £250,000 in 2002 and thought he could retire on it. He built a house over here and, gradually the cash dwindled to almost nothing. He lives on a UK state pension now and is desperate to sell his house that he built as he is struggling to live. I told him that, had he invested in UK property back in 2002 after he built his house here, I estimated his income from the property rental would be close to £1,000 STERLING. The colour drained from his face.

I am writing to you to express my deep concern about developments since the 20th February 2015 Eurogroup agreement, which was preceded two days earlier by a letter from our Minister of Finance* outlining a number of issues that the Eurogroup ought to resolve, issues which I consider to be important, including the need:

(a) To agree the mutually acceptable financial and administrative terms the implementation of which, in collaboration with the institutions, will stabilise Greece's financial position, attain appropriate fiscal surpluses, guarantee debt stability and assist in the attainment of fiscal targets for 2015 that take into account the present economic situation.

(b) To allow the European Central Bank to re-introduce the waiver in accordance with its procedures and regulations.

(c) To commence work between technical teams on a possible new Contract for Recovery and Development that the Greek authorities envisage between Greece, Europe and the International Monetary Fund, to follow the current Agreement.

(d) To discuss means of enacting the November 2012 Eurogroup decision regarding possible further debt measures and assistance for implementation after the completion of the extended Agreement and as a part of the follow-up Contract.

Based on the in-principle acceptance of this letter and its content, the President of the Eurogroup convened the 20th February meeting which reached a unanimous decision expressed in a communiqué. The latter constitutes a new framework for the relationship between Greece, its partners, and its institutions. More precisely, the 20th February Eurogroup agreement stipulated a number of points outlining this new framework and process, including: (a) The Greek authorities will present a first list of reform measures, based on the current arrangement, by the end of Monday, February 23. The institutions will provide a first view whether this is sufficiently comprehensive to be a valid starting point for a successful conclusion of the review. This list will be further specified and then agreed with the institutions by the end of April. (b) The Greek authorities have expressed their strong commitment to a broader and deeper structural reform process aimed at durably improving growth and employment prospects, ensuring stability and resilience of the financial sector and enhancing social fairness. The authorities commit to implementing long overdue reforms to tackle corruption and tax evasion, and improving the efficiency of the public sector. In this context, the Greek authorities undertake to make best use of the continued provision of technical assistance. (c) We remain committed to provide adequate support to Greece until it has regained full market access as long as it honours its commitments within the legal framework. Based on this common ground, the Minister of Finance sent to the President of the Eurogroup a letter, dated 23rd February 2015, with the aforementioned "first list of reforms" [see

(a) abovel proposed by the government. On 24th February 2015 the said "first list" was accepted by the institutions as "sufficiently comprehensible to be a valid starting point for a successfully conclusion of the review" by 20th April 2015. In order to expedite the process, the Ministry of Finance sent a letter to the President of the Eurogroup on 5th March 2015 urging that the process of technical discussions on specifying further the "first list of reforms" begin immediately. In the same letter the Minister of Finance attached seven examples of how the reforms in the "first list" could be developed and specified further. Following a positive reply by the President of the Eurogroup (dated 6th March 2015) and the subsequent Eurogroup meeting of 9th March 2015, the first round of discussions of the Brussels Group (comprising of the four institutions - EC-ECB-ESM-IMF - plus the technical team of the Greek government) took place, in Brussels, on Wednesday 11th March dealing with both political and technical issues. At that meeting it was also decided that technical teams of the institutions would travel to Athens on the following day for on-site fact-finding to assist the Brussels Group negotiations. In the context of the above, I feel it is critical to alert you to a number of developments which are either undermining the spirit of the agreement reached or making their fulfilment perilously difficult.

(a) On 4th February the European Central Bank lifted the waiver for minimum credit rating requirements for marketable instruments issued or guaranteed by the Hellenic Republic, while declaring that the waiver would be restored when an agreement was reached at the level of the Eurogroup.

Moreover, even since the Greek banks were referred to the Bank of Greece's ELA facility, the ECB has been raising the ELA's ceiling at shorter intervals than normal and at rather small increments that incite speculation and spread uncertainty vis-à-vis Greece's banking system. Additionally, the ECB determined that Greek banks cannot hold more T-bills than they did on 18th February 2015, thus restricting their participation to well below the Tbill cap. (Please note that, in the summer of 2012, when a new Athens government was in a similar situation to ours, ELA was being expanded generously, the T-bill issuance cap was lifted to allow the government to finance its debt repayments to our creditors, and banks were not restricted to any limit corresponding to a prior date's holding. In that manner the government of the time and the Eurogroup were granted sufficient 'space' to reach an arrangement that allowed the Greek banks to move away from ELA and back to normal ECB financing methods.)

(b) Following past failures (of the previous government) to complete the scheduled reviews, disbursements under the loan agreements with the ESM-EFSF were discontinued (while those of the IMF were similarly delayed), yielding a substantial financial gap in 2014 and 2015. This includes the profits from the ECB's SMP-sourced bond redemptions, which the ECB distributes to member states on the understanding that they be passed onto the Greek government.

Given that Greece has no access to money markets, and also in view of the 'spikes' in our debt repayment obligations during the Spring and Summer of 2015 (primarily to the IMF), it ought to be clear that the ECB's special restrictions [see (a) above] when combined with the disbursement delays [see (b) above] would make it impossible for any government to service its debt obligations. Servicing these repayments through internal resources alone

would, indeed, lead to a sharp deterioration in the already depressed Greek social economy – a prospect that I will not countenance.

Meanwhile, I also regret to report that little progress has been made in the negotiations between the technical teams in Brussels and Athens. The reason for the extremely slow progress is that the institutions' technical teams, as well as some of the actors at a higher level, seem to show little regard for the 20th February Eurogroup agreement and are, instead, committed to proceeding along the lines of the Memorandum of Understanding that predates both the 20th February agreement and 25th January 2015 – the date on which the Greek people elected a new government with a mandate to negotiating the new process established by the 20th February Eurogroup agreement. It is difficult to believe that our partners consider that a successful reform drive can be carried out under such restrictive and pressing constraints, including the financial squeeze that my government is currently labouring under.

The Greek government remains steadfast in its commitment to fulfil its obligations to its partners within the framework of the 18th February letter and 20th February Eurogroup decision. However, I am also obliged to make clear to you that, in order to continue to fulfil our obligations, as we have done up to now, progress has to be made on a number of fronts: (a) After 20th February Eurogroup agreement and the approval of the extension of the MFAFA by member states, and given that the technical discussions with the institutions are under way, the ECB should return the terms of finance of the Greek banks to their pre-4th February 2015 state. (b) The process by which the reforms proposed by the Greek government, and their evaluation, must be immediately clarified so as to make a successful conclusion of the review by the end of April 2015, as well as to specify the recommencement of disbursements with the progress of the negotiations. (c) The process must be specified (as

well as the participants and timetable) by which further arrangements (which my government would like to take the form of a 'Contract for Greece's Recovery and Development' - including provisions on Greece's public debt in the spirit of the November 2012 Eurogroup agreement) will be agreed to before the end of June 2015. In conclusion, Greece is committed to fulfilling its obligations in good faith and close cooperation with its partners. To this purpose we are committed fully to the process specified in the 20th Eurogroup agreement so as to begin immediately the work of implementing reforms crucial to our economy's prospects of long term development within an inclusive Europe. With this letter, I am urging you not to allow a small cash flow issue, and a certain 'institutional inertia', to not turn into a large problem for Greece and for Europe.


